- [1] This decision pertains to an application for a review of a decision, filed by the "UNION OF CANADIAN CORRECTIONAL OFFICERS SYNDICAT DES AGENTS CORRECTIONNELS DU CANADA CSN" (UCCO SACC CSN) under section 27 of the *Public Service Staff Relations Act* (Act).
- [2] Section 27 of the Act provides as follows:

Powers and Duties of the Board

. . .

- 27. (1) Subject to subsection (2), the Board may review, rescind, amend, alter or vary any decision or order made by it, or may re-hear any application before making an order in respect thereof.
- (2) Any rights acquired by virtue of any decision or order that is reviewed, rescinded, amended, altered or varied pursuant to subsection (1) shall not be altered or extinguished with effect from a day earlier than the day on which the review, rescission, amendment, alteration or variation is made.
- [3] In *Union of Canadian Correctional Officers CSN v. Treasury Board (Correctional Service Canada)*, 2001 PSSRB 25 (142-2-356), the Board certified the Union of Canadian Correctional Officers CSN (UCCO CSN) as the bargaining agent for the following bargaining unit:

All employees of the Employer in the Correctional Services Group as defined in Part I of the *Canada Gazette* of March 27, 1999.

In the French translation of decision 2001 PSSRB 25, the UCCO -CSN is identified as the Syndicat des agents correctionnels du Canada - CSN (SACC - CSN).

- [4] In the application leading to decision 2001 PSSRB 25, the applicant was identified as the UCCO SACC -CSN.
- [5] On March 16, 2001, the UCCO SACC CSN asked the Board to amend the certificate issued pursuant to decision 2001 PSSRB 25 by replacing the references to the UCCO CSN and the SACC CSN with a reference to the "UNION OF CANADIAN CORRECTIONAL OFFICERS SYNDICAT DES AGENTS CORRECTIONNELS DU CANADA CSN". The Board is of the view that, by its letter, the UCCO SACC CSN asked it to amend decision 2001 PSSRB 25 accordingly.

Decision Page: 2

[6] In the circumstances, the Board considers it appropriate to grant the UCCO - SACC - CSN's request and is substituting the latter's name for those of the UCCO - CSN and the SACC - CSN. Therefore, decision 2001 PSSRB 25 is amended accordingly.

[7] A new certificate will be issued.
