DECISION

- [1] On March 21, 2001, I rendered a decision between Constance Auclair and others (grievors) and the Library of Parliament (employer): 2001 PSSRB 30 (466-LP-285 to 323). That decision concerned a Special Pay Adjustment (SPA) that the Treasury Board had paid to some of its employees represented by the Public Service Alliance of Canada and the applicability of the SPA to the grievors as employees of the Library of Parliament.
- [2] In my decision, I denied the grievances on the basis that the grievors' onus of proof had not been met.
- [3] Three grievors sought judicial review of my decision and the matter was duly heard before the Honourable Mr. Justice Kelen. In his decision in *Auclair v. Canada (Library of Parliament)*, 2002 FCT 777 issued on July 11, 2002, Mr. Justice Kelen allowed the application for judicial review and set aside my decision, with a direction that the grievances be allowed.
- [4] In accordance with Mr. Justice Kelen's decision, the grievances are hereby allowed.
